**ARTICLES OF INCORPORATION
OF
THE NATIONAL PARTNERSHIP ON ALCOHOL MISUSE AND CRIME**

TO:
DEPARTMENT OF CONSUMER AND REGULATORY AFFAIRS
BUSINESS & PROFESSIONAL LICENSING ADMINISTRATION

We, the undersigned natural persons of the age of eighteen years or more, acting as Incorporators of a corporation under the NON-PROFIT CORPORATION ACT (D.C. Code, 2001 edition, Title 29, Chapter 3), adopt the following Articles of Incorporation:

FIRST: The name of the corporation is: National Partnership on Alcohol Misuse and Crime (hereinafter referred to as the “Corporation.”)

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the Corporation is organized are attached hereto as Exhibit A and incorporated herein by reference for all purposes.

FOURTH: (1) The Corporation shall have members; (2) The members shall not be divided into classes; (3) Any agency, organization, association, or person may join in accordance with the Bylaws and subject to the Board’s approval; (4) Members will have equal rights and responsibilities with the exception that anyone not employed by a governmental entity may join and maintain membership only if they pay dues in an amount determined by the board according to the Bylaws; (5) Only Board members will have voting rights.

FIFTH: Directors will be elected according to the Bylaws (attached).

SIXTH: (1) The internal affairs of the Corporation will be regulated according to the Bylaws (attached); (2) If the Corporation is dissolved or liquidated, the assets shall be used to pay any outstanding debts. Any remaining funds shall be donated to a non-profit entity that addresses offenders with alcohol misuse issues.

SEVENTH: The Corporation's Initial Registered Agent in the District of Columbia is National Registered Agents, Inc. The Agent's Registered Office Address is 1090 Vermont Avenue, NW, Suite 910, Washington, D.C., 20005.
